#### General use

DO NOT use or press down on the Tablet screen with any sharp objects, they may scratch or damage the LCD screen.

- 1. THE TERMS OF THIS WARRANTY DO NOT AFFECT YOUR STATUTORY RIGHTS UNDER ANY APPLICABLE NATIONAL LAWS.
- Your Tablet is warranted to be free from defects in material and workmanship arising under normal use and service, for 24 months from the original date of receipt of Your Tablet when brand new.
- 3. Supplier's obligation under this warranty shall be to repair or replace the Tablet or any components free of charge to You, in the event of any failure or defect covered by the warranty arising during the warranty period, unless repair or replacement is impossible or disproportionate in relation to its cost.
- 4. Supplier may use newly manufactured or a refurbished service part at its option to repair Tablet.
- 5. This warranty is valid in the United Kingdom.
